#### Message from Leadership: Finding Hope in the Face of a Pandemic

The Head Start community has always known we are much stronger when we act together. This past year has been one of many successes, and one of many challenges. Despite the ongoing public health crisis we face, Luzerne County Head Start, Inc. (LCHS) remains committed to its mission: To enhance the quality of life for low income children and their families in Luzerne and Wyoming Counties.

At the start of the 2019-2020 school year, an increase in state funding allowed LCHS to serve an additional 72 children in our community. We opened a new classroom in the Kistler Elementary school in the Wilkes-Barre Area School District and added a third Head Start classroom on the campus of Luzerne County Community College. For the first time in several years, we expanded our presence to the Crestwood School District and later opened a new center with one Head Start classroom at the Dallas United Methodist Church. We added a third support person to each of our Head Start classrooms and focused on trauma-informed training for all staff. We worked to install new safety measures in our buildings and continued to develop relationships with key community partners in order to help our children and their families be successful. The progress we made is truly inspiring, and we are so proud of our staff for the tireless work they have done.

The spring of 2020 brought a set of challenges we have never experienced. In mid-March, LCHS was forced to close its doors for the first time in its 55 years of existence and transition to distance learning in order to protect the health and safety of our children, families and our staff as the COVID-19 virus spread throughout our community. But, our hardworking staff rose to the occasion, taking learning from the classroom to the computer in just two weeks. Since then, we've adopted new methods and protocols to help our families and their children get the services they need. As we navigate through these new and unexpected challenges brought on by COVID-19, we continue to stay connected to our children and their families. Despite the changes we've made, we remain committed to our core mission: To coalesce, inspire, and support the Head Start field as a leader in early childhood development and education.

As we begin another year of helping young children and their families grow and thrive in a supportive and nurturing environment, we are taking extra precautions to ensure everyone remains safe. As we move toward reopening our doors, we are committed to providing the services young children need for their early development. LCHS believes that every child, regardless of their circumstances at birth; has the ability to reach their full potential. We are, and always have been in this together, and it is our privilege to continue to bring the Head Start model to life.



EARLY HEAD START SITES







The 2020 Indicators Report developed by The Institute for Public Policy & Economic Development states that about 24% of eligible 3 & 4 year old children were enrolled in a high quality Pre-K program in Luzerne County. According to the Office of Child Development and Early Learning's most recent Reach and Risk Assessment, 31% of children in Luzerne County and 17% of children in Wyoming County under the age of 5 are living in economically high risk families with incomes at or below 100% of the federal poverty guidelines.






### ADDRESSING SUBSTANCE ABUSE AND THE OPIOID **CRISIS AT LCHS**

For the first time, LCHS began its use of the Substance Use Disorder (SUD) tool. The tool is a questionnaire that was developed to identify and assist families who are at risk of substance abuse. Every family is asked to complete the questionnaire at the beginning of the program year.








## LCHS STAFF BEGINS TRAUMA-INFORMED CARE TRAINING

Adverse childhood experiences (ACEs) are potentially traumatic experiences that occur in childhood. In order to help staff learn the importance of trauma-informed care, LCHS partnered with Lakeside Global Institute near Philadelphia. During the 2019-2020 school year, staff attended several in-person meetings and trainings alongside mental health professionals that helped them to develop the skills they need to properly handle some of the traumatic situations many of our children and their families face. These opportunities have allowed LCHS



staff to obtain the skills they need to better support those who experience trauma.



### SCREENING. ASSESSMENT AND CHILD OUTCOMES

LCHS is committed to supporting children and families with school readiness, self-sufficiency and success in life. Our program provides children with comprehensive health, nutrition, and other family support services, as well as a developmentally appropriate early childhood education.


LCHS uses Teaching Strategies Gold (TSG) as the assessment tool for our Head Start program and Hawaii Early Learning Profile (HELP) as the assessment tool for our Early Head Start program. Both tools support the goals and objectives of the curriculums we use in our early learning programs.

The graphs on this page represent the percentage of children meeting or exceeding the age-appropriate skills from fall of 2019 to spring of 2020. \*PLEASE NOTE: Early Head Start child outcomes were not calculated for the spring of 2020 due to the closure of LCHS facilities amid the COVID-19 pandemic.


# EARLY HEAD START CHILDREN 0 TO 3-YEARS-OLD



#### SERIES OF PARENTING CLASSES OFFERED TO FAMILIES AT LCHS



Head Start/Early Head Start families take part in parenting classes at LCHS

Luzerne County Head Start believes that a parent is a child's first and most important teacher. To promote the relationship between parents/caregivers and their children, LCHS held a series of parenting classes called "Understanding Children." The six-session series of classes took place at LCHS's Head Start center in Wilkes-Barre and was funded through The Luzerne-Wyoming Counties System of Care grant, which is held by Luzerne-Wyoming Counties Mental Health and Developmental Services. Trained mental health professionals from Lakeside Global Institute, a company based in the Philadelphia area, taught parents how to focus on better understanding their children's' behaviors, interactions and needs. Families also had the opportunity to talk with other families about their experiences with parenting.

# TRANSITION

Preschool children make the transition into kindergarten more successfully when their schools and families prepare together, and when their preschool and kindergarten teachers connect. LCHS has a system in place to help children transition from one program to the next. This includes the transition from Early Head Start to Head Start and Head Start to kindergarten.

#### SUMMER LEARNING EXPERIENCE GOES VIRTUAL

Navient and LCHS partnered to offer Jump Start, a summer learning experience to help 30 three and four-year-old children get a "jump start" to their early education. The summer program was held virtually this year, due to the COVID-19 pandemic. Fifteen children in two separate Google classrooms logged on virtually for the four-week program. Each week, teachers connected with families to make sure their needs were





met. They also dropped off school supplies at the children's homes so the children had everything they needed to learn. Staff held live sessions with their students and created video lessons that demonstrated a learning activity children were asked to complete. The children who participate in Jump Start attend Head Start the following program year.

# SUPPORT AND DISTANCE LEARNING DURING A PANDEMIC

# EDUCATION SHIFTS FROM THE CLASSROOM TO THE COMPUTER

In the spring of 2020, LCHS was forced to physically close its doors to children and their families due to the COVID-19 virus. Early childhood services then transitioned to virtual learning. LCHS was awarded a federal grant through the CARES (Coronavirus Aid, Relief and Economic Security) Act in the amount of \$707,440 to fund these at-home services.







#### SHINING A LIGHT ON HEAD START STAFF: NURSE EVA

Several employees were recognized for their commitment to LCHS, our students and their families as we transitioned from in-person services to virtual learning. "Nurse Eva" who serves as regional nurse at LCHS's Mehoopany, Tunkhannock, Back Mountain and Westmoreland centers was recognized by her co-workers for going above and beyond to do safety and health activities for students. As the pandemic unfolded, she recorded videos while playing her guitar, used actual playground equipment for safety lessons, and continuously provided the staff and children with motivation throughout the virtual learning process. LCHS would like to thank Nurse Eva, and all healthcare workers who selflessly cared for those in our community throughout the COVID-19 pandemic.





#### **CALL FOR HELP ANSWERED**

Early Head Start (EHS) mom, Keisha, had fallen into some hard times during the COVID-19 pandemic. Her husband had to quarantine for one month and was unable to work, leaving the family with one income. Meanwhile, Keisha's two-year-old daughter, Harmony was in need of a pair of new children's eyeglasses. The loss of income made it impossible for Keisha to purchase new glasses for Harmony. Keisha told her EHS



family educator about Harmony's need and that she could not afford the expense. With the help of EHS







# LCHS TAKES PART IN NHSA'S "COVID-19: DESTINATION REOPENING PLAYBOOK"

Leaders from LCHS took part in the National Head Start Association's (NHSA) task force that created the "COVID-19: Destination Reopening Playbook." Dawn Smith, director of operations at LCHS, and Deb Siglin, health specialist, were among 43 individuals from across the country that helped put together the publication. The document aims to help Head Start agencies nationwide safely come back into service during the COVID-19 pandemic, so children and their families can get the services they need to be successful in their early development. Following the release of the national playbook, LCHS put together its own COVID-19 task force, which is made up of individuals in our agency and community who help provide guidelines toward LCHS's reopening plan.

#### PA's Second Lady Visits Head Start, Promotes Participation in 2020 Census

Ms. Fetterman stopped by the Head Start center to spend some time with the preschool children in classroom #18, where she read the book, "Everybody's Somewhere" by Cornelia Spelman. She left the book for the children to add to their classroom library.



#### Alumni Luncheon Canceled; Scholarships Still Awarded

For the first time since it began in 1987, LCHS made the difficult decision to cancel its 2020 alumni scholarship luncheon due to COVID-19. The event celebrates the opportunities Head Start and Early Head Start provides to our community's most vulnerable children and their families. It also recognizes our hard-working staff for their years of dedication and honors former Head Start students with scholarship awards. Thanks to the support of our community, LCHS was still able to provide scholarships to Head Start alumni who plan to pursue post-secondary educations. Twenty high school seniors from eight school districts in Luzerne and Wyoming Counties were awarded scholarships totaling \$18,500 as part of the LCHS Alumni Scholarship program. To date, LCHS alumni have been awarded \$275,250. The scholarships are funded through private sponsors, such as local businesses, organizations and community



#### Head Start Honored with Healthy Workplace Award

CHS was the recipient of the Greater Wilkes-Barre Chamber of Commerce's 2019 Healthy Workplace Award. The Healthy Workplace Award is presented to a business or businesses in Luzerne County that promotes health and wellness within its organization. Over the past year, LCHS's health and wellness committee worked diligently toward promoting health and wellness initiatives in the workplace. Additionally, LCHS's employee wellness program allows all employees the option to receive flu shots, blood pressure checks and bone density tests. LCHS was one of four organizations in Luzerne County to receive the award.



#### Increased Funding Allows for Additional 72 Head Start Children

An increase in state funding allowed LCHS to provide services for an additional 72 children during the 2019-2020 program year. For the first time in several years, LCHS expanded its presence to the Crestwood School District, where our agency opened a Pre-K Counts classroom at Fairview Elementary school. LCHS also opened a Pre-K Counts classroom at Kistler Elementary school in the Wilkes-Barre Area School District. Additionally, our agency added a third Head Start classroom on the campus of Luzerne County Community College. Later in in the Back Mountain region at Dallas United Methodist Church.

#### Inaugural "Walk For Wellness" Goes Virtual

In order to promote health and wellness of staff, LCHS's wellness committee planned to hold its inaugural "Walk for Wellness" event on June 5 at Kirby Park in Wilkes-Barre. The event was put together as a way for LCHS employees to take a break from their regular job responsibilities and enjoy some time outdoors with co-workers. Activities, snacks and wellness giveaways were all planned to be part of the event. In May of 2020, LCHS decided to turn the event into a virtual walk for wellness due to the COVID-19 pandemic. Staff was encouraged to go for a walk, send photos and submit a form that logged their distance. The photos were posted on LCHS's Facebook page as a way to share their results with co-workers and the community.

























# LUZERNE COUNTY HEAD START BUDGET & FINANCIALS

Results of the 2018 financial audit of Luzerne County Head Start, Inc. reported no findings or material weaknesses.


# 2019 FUNDING SOURCES
